

TERMS AND CONDITIONS FOR CIB MEGA BONANZA 2018 CAMPAIGN

Terms and Conditions

1. These Terms & Conditions shall govern the CIB Mega Bonanza 2018 Campaign (“Campaign”) commencing from 1 January 2018 to 31 December 2018 (or upon reaching the campaign set target, whichever is earlier) (“Campaign Period”).
2. The Campaign is opened to new customers who sign up or existing customers who upgrade to Corporate Internet Banking (CIB) Transaction package.
3. To participate in the Campaign, customers are required to perform the following to be considered as activated Transaction Package user;
 - 3.1. **Payment Module**: Sign up or Upgrade to CIB Transaction Package, **AND**
 - 3.2. **Collection Module**: Sign up to one of the Collection Modules under CIB i.e. JomPAY/FPX/Direct Debit **OR** sign up to Affin Bank Merchant POS terminal Facility
4. The campaign is open to the following customers
 - 4.1. New Customers
 - 4.1.1 All customers who open a Current Account who wish to sign up to CIB transaction and any collection module.
 - 4.2. Existing Customers
 - 4.2.1 Affin Bank Customers with Current Account who sign up to CIB Transaction Package and any Collection Modules
 - 4.2.2 Existing CIB Customers with Transaction Package who wish to sign up with any Collection Modules
 - 4.2.3 Existing CIB Customers with Inquiry Package who wish to upgrade to Transaction Package and sign up to any Collection Modules
5. To be in the running for campaign rewards, customers must activate both Payment and Collection Module sign up during the campaign period.
6. There are two (2) types of Campaign Rewards; Instant Reward and Grand Prize.
7. **Instant Reward**
 - 7.1 Customer who have signed up to Payment and Collection module shall be eligible for special transaction fee for payments via CIB.
 - 7.2 The campaign transaction fees will expire 1 year after the eligible date (From the date the customer transact during the campaign period) and will be reverted to normal fees thereafter.
 - 7.3 The bank has the right and not limited to revise, uplift or terminate the special rates by notifying the customers 21 days prior to the change.
 - 7.4 Customers can only enjoy the special rates by using payments via CIB, the rates are not applicable to any other channels.
 - 7.5 The special rates are subject to 6% GST and applicable to all companies and/or accounts linked under CIB
 - 7.6 Customers who requested for full waiver of the fee for whatsoever reasons shall be disqualify from the campaign rewards and other prizes.
8. **Grand Prize Reward: Cash worth RM 200,000**
 - 8.1. The Grand Prize winner will be determined based on entries which customers earns by performing payments or collections via CIB. Top 20 customers with the highest monthly transactions will earn one (1) entry which will be accumulated until the draw.
 - 8.2. Winners who have been chosen for first draw are not eligible for the second draw. However, they may still continue to enjoy the Instant Reward.
 - 8.3. The Cash Prize will be credited into the Winner’s account and cannot be converted.
 - 8.4. Winners will be selected via draw based on accumulated entries and will be announced via Affin bank’s Website and Affinonline.com website and the decision is final.
